### Fund Objective and Investment Policy

The investment objective of the fund is to provide investors with diversified exposure to predominantly the South African equity market. The fund aims to achieve long term capital growth. Investments to be included in the fund will, apart from assets in liquid form, consist solely of collective investment schemes. The fund will be actively managed and may have exposure to general equity as well as specialist portfolios. The equity exposure will be at least 80% at all times, and the fund may hold up to 45% in foreign assets.

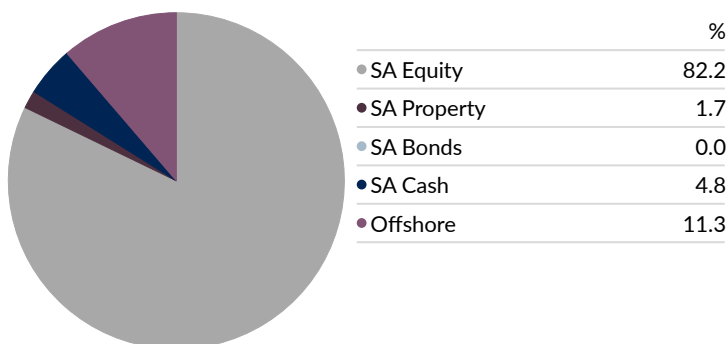

## Portfolio Managers Comment

The FG SCI Mercury Equity Fund of Funds returned +2.17% for the month of April, outperforming the benchmark FTSE/JSE All Share Total Return index which returned +1.65%, while underperforming the peer group average return of +2.82%. Global financial markets had a strong rebound with geopolitics remaining the primary driver of markets in April. The month began on a constructive note as a ceasefire was agreed on the 8th of April, paving the way for initial negotiations between the US and Iran on the 11th of April. Global equity markets diverged depending on their reliance on oil imports from the region. While no resolution was achieved, the ceasefire marked a tentative step toward de-escalation, and the Strait of Hormuz continues to be a critical chokepoint for global oil flows. Headline US inflation rose from 2.4% to 3.3% in April, driven primarily by a 12.5% increase in energy costs. At its most recent meeting, the US Federal Reserve under Chairman Jerome Powell left interest rates unchanged in the range of 3.5% to 3.75%. Locally, South Africa's annual inflation rose to 3.1% in April from 3%, in line with consensus expectations. The impact of higher fuel prices was not yet reflected in the April data, as the adjustment only took effect at the start of April. There was no monetary policy meeting held in April however the SARB (South African Reserve Bank) has reaffirmed the 3% inflation objective. The market is now pricing in interest rate hikes for the rest of the year, a change from the expectations of interest rate reduction before the Iran conflict started. Local listed property (SAPY) gained back some of its losses from the previous month returning +5.40%. Local listed equities returned +1.65% over the month; resources (-2.30%) detracted from performance, while financials (+4.43%) and industrials (+3.17%). GFM Global Equity Fund was the best performing underlying fund, returning +7.25% for the month. No changes were made to the fund over the month.

As investment manager of the Fund, CiGFM will earn an investment management fee of up to 0.565% on the A class and up to 0.6925% on the C class, on all such investments.
